Committee Reports

<u>Prevention:</u> Prevention Committee was cancelled and rescheduled for Monday, August 6th.

<u>Treatment</u>: Speakers were discussed for Faces of Change 2012. The Committee nailed down the majority of the FOC speakers and schedules and only need confirmation from two before finalizing the schedule and registration flyer. Registration fee will be determined once a meal price/person is determined. Jennifer will be contacting Bob Mitchell for finally details, Laura will contact Kathy Reidford and also look up SAC gas per diem. Laura will ask Katy to contact Dr. Mackey regarding a speaking position.

<u>Law Enforcement:</u> Countermeasure fees for June totaled \$11,614.13. ISP assisted VCSO and EPD in DUI checkpoint on 6/2 at SR 62 and I164; 66 vehicles were checked, 12 sobriety checks were given,

0 DUI arrests were made, 1 marijuana arrest was made, and 1 warrant in sat patrol outside of checkpoint. Vanderburgh County had 14 crashes involving alcohol, illegal and prescription drugs in June. 4 of those had injuries, 6 people we injured. 8 DUI arrests and 7 minor consumptions arrests made by ISP. EPD and VCSO stats are not available. Excise Police worked a party on Redbank Rd. on June 23-24. An undercover officer went in to find the party sold cups for \$7 and all alcohol was free. Party was using alcohol from a bar that had closed. 9 underage drinking tickets, 1 adult to minor ticket, and bartender was ticketed for sale without permit and sale to minors.

Project Updates/Discussion

Wally spoke about the SAC hosting a Methamphetamine training on Friday, September 7th at the Holiday Inn on HWY 41. Judge Brett Neimeier will be helping sped the word of the event by taking information to the County Council, County Commissioners, and City Council in hopes that they will then also promote the event. Old Business
